What?

- Social Security number and account balances
- Payment history and credit history
- Mortgage rates and payments and checking account information

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Citizens Bank of Lafayette has no affiliates.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Citizens Bank of Lafayette does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partner(s) include Our joint marketing partners include credit card companies*
